

## COOKIES POLICY

Subject to your consent where required by applicable law, our lottery website (hereinafter the "**Website**") uses cookies and similar technologies (hereinafter "**Cookies**").

The company **LES GRANDS CHAIS DE FRANCE SAS** (hereinafter the "**Company**"), undertakes to respect your privacy in the context of its use of Cookies on the Website.

By continuing to use the Website, you accept the setting of our Cookies and acknowledge that you understand the terms of our Cookies policy.

### **A. WHAT IS A COOKIE?**

A computer cookie, also known as a "connection tracker", is the equivalent of a small text file that may be stored on a computer or mobile device (tablet, mobile phone, or any other device optimized for the Internet) of the Participant by the websites he or she visits.

Cookies are managed by the Participant's Internet browser, which will store them for a certain period of time and send them back to the web server each time the Participant reconnects. Cookies have a limited lifespan and are deleted by the browser once they have expired. Only the company that deposits the Cookie is likely to read or modify the information contained in this Cookie.

### **B. WHY DO WE USE COOKIES?**

The Company uses Cookies for different purposes. Some Cookies are necessary for the operation and your use of the Website; others have more incidental purposes.

In this case, here, Cookies are used to make the Website work more efficiently and to track navigation for statistical purposes. A Cookie cannot give access to information about the Participant that he or she does not wish to share.

In order to enable the Participant to assess the usefulness of a particular Cookie, a presentation of the different types of Cookies follows this paragraph.

### **C. WHAT COOKIES DO WE USE?**

There are two types of Cookies on our website:

#### **a. Strictly necessary Cookies: navigation Cookies**

Some Cookies are necessary for the proper functioning of the Website in order to allow the use of its features and services. You may not therefore refuse their use, otherwise the Website may not be available to you, nor may certain features or services be offered.

Technical Cookies collected from the Website allows the Company to remember your choices regarding, for example, the language used on the Website, for customization purposes, or to make your experience of using our Website easier.

These Cookies will not be used for advertising purposes, nor to remember which pages you have visited on the Internet.

#### **b. Unnecessary Cookies; third-party Cookies**

The Company uses unnecessary Cookies that do not affect the quality of your browsing experience or the basic functionality of the Website. These Cookies have several purposes, including:

- They enable statistical analysis of information from Website users such as volume of visits and use, browsing patterns, number of new visitors and Website performance, as well as demographic data, marketing campaign activity and orders placed. These are known as "**audience measurement**" cookies;
- They facilitate interaction with social networks. These are known as "**social network**" cookies;
- They embed content from third-party services and may set their own cookies to provide required functionality and store preferences. These are known as "**embedded content**" cookies.

In accordance with what is indicated in the paragraph "E. HOW DO I MANAGE MY COOKIES ON THE WEBSITE?", the effective use of these Cookies depends on your prior express consent, via a checkbox on the Cookie banner that appears when you arrive on the Website.

These Cookies enable the Company to improve the interest, ergonomics and operation of the services offered on the Website (for example, the pages most often consulted, searches by Internet users in the Website's engine, etc.).

#### **D. HOW LONG DOES A COOKIE LAST?**

##### **a. With regard to the conservation of choices**

Application of the CNIL recommendation: conservation of the Participant's choices (both consent and refusal) for a maximum period of **13 months**.

##### **b. With regard to the maximum storage period for information recorded by Cookies in the terminal**

Cookies are required to be stored for a maximum of 13 months. Once this period has expired, the Cookie will be deleted from the Participant's computer.

A Cookie collected with the consent of a Participant shall be deleted 13 months after the consent has been obtained unless consent has been given again by the Participant.

#### **E. HOW DO I MANAGE MY COOKIES ON THE WEBSITE?**

With the exception of the Cookies considered strictly necessary, the unnecessary Cookies mentioned above are subject to the Participant's consent and will be installed on his/her device only if the Participant accepts them

## **In order to accept or refuse the Cookies, you can setup your Internet browser**

You can deactivate and/or delete these Cookies at any time by going to your browser. You can accept or reject Cookies on a case-by-case basis or reject them systematically once and for all.

You can choose to block Cookies or have your browser warn you when a site attempts to set a Cookie on your device.

In this context, the Company informs you that you can set your browser to refuse the implementation of Cookies. Each browser has a different configuration for managing cookies and your choices. This is described in the help menu of your browser, which will tell you how to change your wishes regarding Cookies.

- **Safari:** In the **Safari** browser window, select the Safari drop-down menu, choose “Preferences”. Click on the “Privacy” icon. Select or deselect the “Block all cookies” box.

- **Opera:** In the **Opera** browser window, go to “Settings”. Click “Advanced” in the left sidebar, then click “Privacy & Security.” Under “Privacy & Security,” click “Site Settings.” Click on “Cookies and site data”. Enable or disable “Allow sites to save and read cookie data (recommended)”.

- **Chrome:** In the **Chrome** browser window, at the top right, click “More”, then “Settings”. Click on “Privacy and security”, then on “Third-party cookies” and select your preferences.

- **Microsoft Edge:** In the **Microsoft Edge** browser window, at the top right, click “...”, then “Settings”. In the menu on the left, click on “Cookies and site permissions”. Under “Cookies and stored data”, click “Manage and delete cookies and site data”, then select your preferences.

- **Firefox:** In the **Mozilla Firefox** browser window, click the menu button and select “Settings”. Select the “Privacy & Security” panel. In the “Enhanced tracking protection” section, select “Custom” and check the “Cookies” box. Use the drop-down menu to choose your preferences for the types of cookies to block.
